1. Mr. Hartsock has violated the condition of, "... abide by the Court Monitoring Services directives."

SUBSTANTIATION:

1. On April 26, 2016, Mr. Hartsock was placed on monitored probation with this agency. Mr. Hartsock was Court ordered to report to Linn County Mental Health and follow through with the assessment and complete any treatment or after care recommended as a result of that assessment. Mr. Hartsock has reported to this agency that he has completed an assessment and no further treatment is recommended; however, he will not provide any proof of this. Mr. Hartsock does not want any of his medical records released to this agency or to the Court. This agency has explained to Mr. Hartsock on several occasions that we do not need to see any of his medical records and we do respect his privacy, but we do need to know that an assessment has been done and what the results were. This agency has also requested to Mr. Hartsock on several occasions that he sign a release of information so that we can access the assessment. Mr. Hartsock states that all ROI's have been signed, but he still does not want those records released. Mr. Hartsock has stated to this agency that if the Court wants any records, then they will need to subpoena him or Linn County Mental Health for them. It is recommended that Mr. Hartsock's judgment be amended and it state that "Upon request, sign release for mental health evaluation and treatment information to be disclosed to the probation officer, the Court and/or the District Attorney."
